Through its network of 146 agencies in 20 counties, food is distributed through on-site programs, pantry programs and voucher programs. Throughout the network, 64,869 boxes of food were distributed to families, including 23,308 that were distributed through the mobile pantry program to our outlying communities. SPFB was in its fourth year of participating in the Commodity Supplemental Food Program and 26,281 commodity food boxes were distributed to seniors.

Child Nutrition Programs: SPFB has both an after-school feeding program during the school year and a summer feeding program during the summer months. Hot nutritious meals and/or snacks are served at the sites and

GENERAL EXPLANATION

On January 30, 2020, the World Health Organization declared the coronavirus outbreak a "Public Health Emergency of International Concern" and on March 10, 2020, declared it to be a pandemic. Actions taken around the world to help mitigate the spread of COVID-19 include restrictions on travel, quarantines in certain areas, and forced closures for certain types of public places and businesses. The pandemic and actions taken to mitigate it have had and are expected to continue to have an adverse impact on the economies and financial markets of many countries, including the geographical area in which the Organization operates. It is unknown how long these conditions will last and what the complete financial effect will be to the Organization.
